



Small Employer Occupational Health and Safety Course (SEOHS)

Note that this course is mandatory for one representative from every company that plans to become SAFE certified using either the SEBASE or ISEBASE audit. This requirement cannot be assigned to a contractor or consultant.

- **Independent Small Employers (ISEBASE)** - 2 to 5 employees (and contractors), including company owner
- **Small Employers (SEBASE)** - 6 to 19 employees (and contractors), including company owner

It is highly recommended before enrolling in the course that your company also be registered with the SAFE Companies Certification program.
